It is further **ORDERED** that the Defendant may also be subject to additional limitations and/or requirements imposed by the Court or by the Agency, pursuant to the Agency's Rules and Regulations.

It is further **ORDERED** that failure to pay all fees due to the Agency in connection with the ordered monitoring shall constitute a violation of this order.

It is further **ORDERED** that Defendant contact the Agency within 24 hours of issuance of this Order to schedule an appointment. Failure to do so will be considered a violation of this order.

It is further **ORDERED** that, on determining that the Defendant has violated a condition of home detention monitoring, the Agency is to notify the following parties ("Notification Recipients") as soon as possible, but no later than 24 hours following the violation, as required by Md. Code Ann., Bus. Occ. & Prof. § 20-401(b)(1) and § 20-401 (c)(1):

that, on determining that the Defendant has tampered with or failed to maintain home detention equipment, the Agency is to notify all Notification Recipients set forth above within one (1) hour, as required by Md. Code Ann., Bus. Occ. & Prof. § 20-401 (b)(2) and § 20-401 (e)(2).

It is further **ORDERED** that, on determining that Defendant has entered an area that Defendant is expressly prohibited from entering as a condition of pretrial release ("Exclusion Zone"), the Agency is to notify all Notification Recipients set forth above immediately, as required by Md. Code Ann., Bus. Occ. & Prof. § 20-401 (b)(3) and § 20-401 (c)(3).

It further **ORDERED** that, for those notifications noted above, the Agency shall thereafter file a formal Notice of Violation in the subject case through MDEC as soon as practicable.
